- 1 Complete a Product Returns Authorisation Form.
- 2 Return the completed form to PPG via fax on (02) 8781 0599 marked for the attention of Colleen Ellis/Khai Ha OR email the completed form to nsw.onlinereturns@ppgaust.com.au
- 3 PPG will complete the Internal Section of this form including noting down the Credit Note Number onto your form. This form will be emailed back to you clearly marked as “approved” or “declined”.
- 4 If approved, you will need to attach a copy of this signed and approved form when completing a Request for Refund form.
- 5 Complete the Request for Refund form and email to PPG Accounts Receivable at ar.nsw@pro-pac.com.au. Accounts Receivable will process your refund request within 48 hours.
